The **pandemic** put verifications on the back burner and many teams are still struggling to catch up.





Outdated Process










- Wasting time, faxing printing, scanning, and finding the key to the file room, the right file cabinet, and the right folder.
- Scrambling to scan and upload your documents when an accrediting body asks for them electronically.
- Worrying that the document is filed in the right place so you don't have to ask the provider for it again.



- Use a secure platform for providers to electronically upload their credentialing and recredentialing documents.
- Track and store all documents and communication relating to a provider in one place so you can hold payers and providers accountable if there is a lapse.

Outdated Process










- Visiting dozens of websites, adding the data to a spreadsheet, and storing the documents.
- Sorting your spreadsheet and hoping you don't accidentally delete a column or row.
- Having to double-check multiple places to show the status of your enrollments.

- Customize and save reports that pull realtime data when you need it.

Easier for Providers

Increase provider satisfaction, reduce turnover, and get the information you need faster when you're credentialing online.

Outdated Process










- Asking providers to drop off paper copies of their documents or print, scan, and send them.
- Leaving yourself sticky notes to remember to follow-up with providers and sending reminder after reminder.
- Leaving providers guessing whether you have all the documents you need and when the process might be complete.



- Request electronic documents and include a secure link for the upload.
- Automatically start requesting documents 120 days prior to the document/ certification expiration date.
- Use digital integrations that eliminate manual data entry.



Reduce Manual Tasks

When 47% of credentialers have other responsibilities (according to a 2023 MedTrainer poll), the automation available through modern credentialing is critical to prevent burnout and lost revenue.

Outdated Process



- Using sticky notes, calendar reminders, and emails to keep track of dates, deadlines, and missing documents.
- Checking dozens of websites to verify credentials and exclusions, then tracking in multiple spreadsheets.
- Entering all provider information and details by hand.



- Connect your credentialing and training platforms to your HR system so all your important employee data transfers securely, accurately, and quickly.
- Automate email reminders for recredentialing, privileging, and payer enrollment to maintain your status and maximize reimbursement outcomes.
- Automate processes, such as DEA verification, to save time.




Built-In Redundancies

With turnover rates in healthcare soaring, you need the standardized process and backup plan modern credentialing offers – just in case your in-house credentialer leaves.

Outdated Process
